

Alaska Division of Agriculture Hemp Program

Transportation Permit

Any person subject to Title 11 Chapter 40 must apply for and receive a transportation permit from the division prior to transporting industrial hemp or hemp products in the state in accordance with 11 AAC 40.710.

A transportation permit is not required if:

- Industrial hemp is being transported on a property listed on a registrant's registration prior to submitting a pre-harvest report.
- Transporting industrial hemp seed or propagules to a registered grower
- Transporting industrial hemp products that hold a valid endorsement under 11 AAC 40.400 11 AAC 40.420

Program registrants shall maintain all approved transportation permits for three years and make them available within three days upon the request by the division. The permittee shall provide the operator transporting the industrial hemp a copy of the valid transportation permit including a copy of the applicable program registration. The copy of the transportation permit shall always be in the operator's immediate possession while transporting industrial hemp. If at anytime the operator transporting industrial hemp is asked by a peace officer, the division or a representative of the division, the operator must present a copy of the applicable registration and transportation permit.

Once a transportation permit application is received, the division will review and approve or deny each application within five days of which it was received. An approved permit will be returned to the original applicant with the date received, date approved, and an official stamp of approval in the lower right-hand corner. Without the official stamp, a transportation permit is invalid. The transportation permit application approval form is required to be carried by the transporter.

Directions: Complete all parts of the following application and submit the application, the nonrefundable transportation permit fee, and all required attachments to Alaska Plant Materials Center Hemp Program, 5310 S. Bodenburg Spur, Palmer, AK 99645. The application must be complete, accurate and legible. Be sure to keep a copy of the full application for your records.

The completed application may be filed electronically, mailed, or hand-delivered to the division. All associated fees must be submitted to the division at the time of application. Fees may be in the form of cash, check, money order or the applicant may contact the division at 907-745-4469 to pay electronically.
