#### DESTRUCTION PLAN INSTRUCTIONS

### What is a destruction plan?

The destruction plan is to notify the county agricultural commissioner of anticipated destruction activities and propose a destruction method for approval.

# When should the destruction plan be provided to the county agricultural commissioner?

Any industrial hemp crop that does not meet the requirements of Division 24 of the Food and Agricultural Code must be destroyed in a manner approved by the county agricultural commissioner and in accordance to the timeframe listed below:

- If a laboratory test report indicates a THC content of more than one percent, the destruction must begin within 48 hours and be completed within seven days, after the registrant's receipt of the laboratory test report.
- If a second laboratory test report indicates a THC content of more than three-tenths of one percent, the destruction must be completed no later than 45 days after the registrant's receipt of the second laboratory test report.
- Destruction of non-compliant industrial hemp crops must be completed no later than 45 days after the grower's notification of abatement from the county agricultural commissioner.

The destruction plan must be provided to the county agricultural commissioner at 24 hours prior to the anticipated destruction start date.

#### **PLAN INSTRUCTIONS**

All information provided must be complete, legible, and accurate.

#### **Grower Information**

Grower must complete all sections for the grower information. Email address is optional.

#### **Destruction Site/Cultivar Information**

Grower must complete all sections below for the destruction site.

- Provide the anticipated destruction start date and end date.
- Indicate the county, where the cultivation site to be destroyed is located.
- **Physical address** is the location address of the cultivation site to be destroyed. Information should not differ from registration if it is a registered site. Use cross streets if the cultivation site does not have a physical address.
- Global Positioning System (GPS) Coordinates must be the approximate center of the cultivation site to be
  destroyed and in the format of decimal degrees, up to six decimals with a negative longitude (i.e., 38.574968, 121.492337 NOT 38ºN and 121ºW).
- Indicate the **size** of the cultivation site to be destroyed.
- Include information to describe, locate, and identify the boundaries of the cultivation site to be destroyed in **general description**. A general description is required if the cultivation site does not have a physical address. Assessor's parcel numbers (APN) or operator identification number for Pesticide Use Enforcement can be provided in this section.
- List the **name** of each seed cultivar(s) that is to be destroyed with its corresponding **sample ID number** and **percentage content of THC** if applicable.

## **Proposed Crop Destruction Method**

The proposed destruction method must be approved by the county agricultural commissioner prior to the start of the destruction (Section 4950 in Title 3 of the California Code of Regulations).
