All licensed 2020 hemp growers are required to submit an annual report no later than November 30, 2020. Growers will receive an email with information on how to complete this form. In order to submit this report, you must use the Report Code sent to your email on file. If you did not receive an email or Report Code please reach out to hemp@agr.georgia.gov or 404-586-1140.

- In the Field/Greenhouse section, click on the "Select the Hemp Grow Site" Dropdown. When you click on this screen, a list of the grow sites that you provided in your application will appear in the dropdown. Select one and it will pre-populate the Address, Latitude, and Longitude below.
- NOTE if you do not see your fields/greenhouses in the drop down ensure you are using a recent version of Microsoft Edge, Google Chrome, Mozilla Firefox, or Apple Safari as your internet provider. Internet Explorer is not compatible.

- As you come down the Field/Greenhouse Section, there will be boxes that need to be checked that are specific to the Grow Site.
- The first box asks if the grow site is a field or a greenhouse. If you select field, a box will appear just below asking for the number of acres planted. If you select greenhouse, a box will appear just below asking for the square footage planted in the greenhouse
- The next question asked is "was hemp harvested from this site/greenhouse?" If you harvested, click yes. A box will then appear below asking either for the number of acres harvested or square footage harvested. If you did not harvest, select no and move on to the next question.
- The next question is "Did any hemp require disposal due to THC levels?" If your hemp tested above the 0.3 THC threshold, you should have received a disposal order from the Georgia Department of Agriculture requiring the hemp to be destroyed. If hemp was destroyed for this reason, select yes. Otherwise, select no. If yes is selected, a box will appear below asking for the number of acres/ greenhouse square footage destroyed.
- The last question asked is "Did any hemp require disposal due to other reasons?" If plants were destroyed prior to harvest for factors beyond your control such as environmental (plants died because they were too wet or too dry), insect damage, disease, etc., you would select yes. If yes is selected, a box will appear below asking for the reason why hemp was destroyed. List the reason in this box.
- IMPORTANT If you only have one grow site, you are now finished and can click submit at the bottom. If you have more grow sites, click the plus sign and follow the steps above. You must do this for ALL of your grow sites. Once all grow sites have been entered, click submit at the bottom and you are finished.
